

**Official Rules**  
**Hops in the Hangar Raffle**

- The Hops in the Hangar Raffle (the “Raffle”) is open only to individuals who are 21 years of age or older and are physically present at the Event in Atlanta, Georgia at the time of ticket purchase. Employees of Delta Flight Museum (“Sponsor”), and their affiliates, agencies and representatives and their respective families who are not involved in the administration of the Raffle are eligible to participate. This Raffle is subject to all federal, state and local laws and regulations, and is void where prohibited by law. The Sponsor reserves the right to suspend, cancel or modify the Raffle at any time. Any effort by entrant to misrepresent their eligibility will disqualify that entrant. Entrants who disregard these Official Rules are not eligible to participate or win.
- Licensing. This Raffle is conducted by Delta Flight Museum, a 501(c)(3) nonprofit organization, pursuant to a Raffle License issued by the Sheriff of Fulton County, Georgia License No. insert number, in accordance with O.C.G.A. § 16-12-22.1.
- Timing: The Raffle will be open from February 21, 2026, from 06:00PM EST to February 21, 2026, at 10:00PM EST (“Raffle Period”).
- How to Enter: There is one (1) method of entry. Entrants may enter the Raffle by purchasing raffle tickets at the event only during the Raffle Period. Tickets are priced at **\$15 for one (1) ticket or \$25 for two (2) tickets**. There is **no minimum or maximum number of tickets a person can purchase**. Each ticket purchased constitutes one (1) entry into the raffle. **No online or remote sales are available**. Entrants will not be eligible to win the Raffle unless agreeing to the terms and conditions and truthfully and accurately completing the entry forms as may be required for each form of entry.
- Potential Winners will be randomly selected by physical drawing of raffle tickets from all eligible entries received. Selected potential winners will be contacted to confirm their win and to provide any necessary prize fulfillment details. A representative from Delta Flight Museum or its agency will contact each potential winner via phone or email within seven (7) days after the date of the raffle. If the potential winner does not respond within seven (7) days, the prize will be forfeited, and an alternate potential winner will be selected by randomly choosing another raffle ticket. Odds of winning depend on the total number of eligible entries received. Claimed prizes by winners who then complete all required documentation and affidavits confirming eligibility will be awarded. Sponsor is not responsible for claimed prizes which cannot be used due to the winner’s unavailability and claimed, but unusable or unused prizes will not be substituted. Prizes are not transferable.
- There is no limit on the number of entries per entrant; each raffle ticket purchased counts as one entry. Potential winners must sign an affidavit of eligibility/publicity/liability release before award of prize. If affidavit and release are not signed and returned to the designated representative within two (2) days of prize claim, prize will be forfeited, and an alternate potential winner will be selected by randomly drawing raffle tickets.
- **1 Prize Package** will be provided to winners by Sponsor. The Vacation Prize Package shall include two (2) Round Trip Delta **Main** tickets on Delta to **any Delta Vacations destination** valued at up to \$750

per person and double occupancy hotel accommodations for two (2) (one room), at a participating Delta Vacations hotel or resort, valued at up to \$1000. The total aggregate approximate retail value for the Vacation Prize package is \$2500. [The winner is allowed to redeem the total package value toward any Delta Vacations destination.] The winner must book by September 20, 2026, and travel by December 31, 2026; blackout dates and standard terms & conditions apply. Sponsor reserves the right to modify or substitute the Prize Package at its sole and exclusive discretion and without prior notice to winners. Winners assume sole responsibility for all costs associated with any component of the Prize Package not explicitly outlined above, including without limitation, all federal, state and local taxes which may be incurred as a result of winning the Prize Package and which shall be the sole responsibility of the winners. The Prize Packages are not transferable and not substitutable for cash or cash equivalent. The winner is responsible for ground transportation, food, and any incidental costs not expressly described in the prize description.

- If the Prize Package expressly includes Delta flight certificates, the following terms shall apply:
  - Tickets and certificates are non-refundable and non-transferable.
  - Tickets and certificates issued in conjunction with this promotion have zero cash value.
  - Airfare is not included unless otherwise specified. For certificates which specify the inclusion of airfare:
  - Delta Vacations will provide air transportation via Delta Air Lines from any city in the U.S. 50 or Canada.
  - Travel is permitted on designated flights operated by Delta Air Lines; the Delta Connection® carriers: Endeavor Air, Republic Airways, and SkyWest; and Delta Shuttle® carriers: Republic Airways. Travel via other Delta Air Lines affiliated partner flights is not permitted. The recipient shall be responsible for travel to and from the airport served by such flights.
  - Travel is not permitted on the following dates: March 31 – April 21, November 22 - 26 & December 12 -31, 2025; March 16-April 6, November 21-25 & December 11-31, 2026.
  - Not valid with previously purchased trip. Trip certificate may not be combined with any other coupon, certificates, discount, bonus, infant fare, upgrade, SkyMiles Award Travel or promotional offers/tickets.
  - Trip certificate is not valid with Miscellaneous Charge Orders or Prepaid tickets.
  - Trip certificate is not applicable to Globus family of brands including Globus, Cosmos, Monograms and Avalon.
  - Trip certificate is non-transferable. Positive identification will be required at time of check-in.
  - Purchased certificates are subject to confiscation and you will not be allowed to travel. Only original certificates will be accepted. Certificates will not be replaced. Void if altered.
  - Travel must be roundtrip.
  - Reservations must be made and ticket issued prior to departure.
  - Booking and travel dates must fall into the range as specified.
  - Delta Vacations must make all reservations and issue all travel documentation.
  - Certificate may only be applied towards number of passengers specified on the certificate; passengers must travel on the same itinerary and must be booked through Delta Vacations.
  - Any unused portion of the certificate will not be refunded and cannot be used towards another booking or another service component.
  - Travel agent commission is not paid/earned on a free trip value, taxes, and fees.

- If any component of the trip, air or land, exceeds the value specified on the certificate, recipient is responsible for any balance due and must be paid in full at time of booking.
  - Hotel taxes, state and federal income taxes may apply and are the sole responsibility of the recipient.
  - Checked luggage fees may apply and are the sole responsibility of the recipient. Fees are charged each way and are subject to change. Refer to [delta.com](http://delta.com) for current rates.
  - Changes to reservations, once made, are not permitted.
  - A per ticket surcharge will apply for paper tickets issued in markets where electronic ticketing is available.
  - Substitutions will not be allowed.
  - Space is subject to availability.
  - Winner must be 21 years of age or older.
  - SkyMiles mileage credit and/or Medallion® Qualification Dollars (MQDs) may or may not be awarded.
  - Flight schedules are subject to change without notice.
  - Delta Vacations is the final authority on the interpretation of these rules and reserve the right to change these terms and conditions without prior notice.
  - Standard Delta Vacations Terms and Conditions apply, and are outlined during the booking process; other airline, hotel, or vendor restrictions may apply.
  - Certain destinations may charge taxes or fees not covered by this certificate or Delta Vacations
- The Sponsor is not responsible for misdirected, incomplete, lost, late, or inaccurate entries, nor for technical, hardware, or software failures of any kind, lost or unavailable network connections, or failed, incomplete, garbled or delayed computer transmissions or other errors or problems which may limit or affect a person's ability to participate in the Raffle, whether human, mechanical, typographical, printing, electronic, network or otherwise, relating to or in connection with the Raffle, including, without limitation, errors which may occur in connection with the administration of the Raffle, the processing of entries, the announcement of the prizes or in any Raffle-related materials. In the event of sabotage, acts of God, terrorism or threats thereof, computer virus or other events or causes beyond the Sponsor's control, which corrupt the integrity, administration, security or proper operation of the Raffle, Sponsor reserves the right, in their sole discretion, to modify, cancel or suspend the Raffle. False or deceptive entries or acts will render the entrant ineligible. In the event of cancellation, Sponsor may elect to identify winners and award the Prize from among all non-suspect, eligible entries received up to the time of such cancellation.
  - Except where prohibited by law, by submitting an entry, each entrant for himself or herself and on behalf of their heirs, successor and assigns hereby grants to Sponsor and each's parents, subsidiaries, affiliates, divisions, advertising and promotional agencies, and each of the foregoing entities' employees, royalty-free license to publicize, broadcast, display and/or otherwise use the entrant's name, likeness, city, and state, in any media now known or hereafter devised throughout the world in perpetuity for advertising and publicity purposes in connection with the Promotion, including such usage on the Internet, without further compensation.
  - By entering or participating in the Raffle, entrants agree to be bound by these Official Rules and by the decisions of Sponsor, which are final and binding in all respects. Anyone violating these Official Rules will be disqualified. In addition, each entrant represents and warrants that all information contained in

his/her entry is true and accurate. The Sponsor is not responsible for any printing errors in these Official Rules or otherwise in any materials available at the Raffle Site. Sponsor shall not be responsible for lost, late, misidentified or misdirected entries, or telecommunication or computer hardware or software performance, errors, delays or failures. Sponsor reserves the right to disqualify any individual who tampers with the entry process or the administration of the Raffle.

- **Release and Limitations of Liability:** Except where prohibited, by participating in the Raffle, entrants agree to release, indemnify and hold harmless Delta Flight Museum Air Lines, together with the those working on their behalf, and each of its respective shareholders, owners, franchisees, landlords, subsidiaries, affiliates, promotional partners, prize partners, agents and agencies, and the officers, directors and employees (the “Released Parties”) from and against any damage, injury, death, loss, liability claim or cause of action, either in law or equity, whether known or unknown, asserted or not asserted, that may in any way arise out of participation in the Raffle or receipt, awarding, acceptance, use or misuse of any prize, or any substitute prize including, but not limited to: (a) unauthorized human intervention in the Raffle; (b) technical errors related to computers, servers, providers, printers or telephone or network lines; (c) printing errors; (d) errors in the administration of the Raffle or the processing of entries; (e) late, lost, or undeliverable mail; or (f) injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Raffle or receipt of any prize. By participating in the Raffle, entrants waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages. Entrants agree that in any cause of action, in no event shall the Released Parties be liable for attorneys’ fees and/or experts’ fees and costs. WITHOUT LIMITING THE FOREGOING, THE RAFFLE, ALL PRIZES, AND ALL MATERIALS PROVIDED IN THE RAFFLE ARE PROVIDED “AS IS” WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
- **Disputes:** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Raffle or any prizes awarded shall be resolved individually, without resort to any form of class action, and shall take place exclusively in Atlanta, GA and each entrant expressly consents to the jurisdiction of and venue in such courts and waives all defenses of lack of jurisdiction and inconvenient forum with respect to such courts; and (b) ANY CLAIMS, JUDGMENTS AND/OR AWARDS SHALL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS ASSOCIATED WITH ENTERING THIS RAFFLE. ENTRANT HEREBY WAIVES ANY RIGHTS OR CLAIMS TO ATTORNEY’S FEES, INDIRECT, SPECIAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ENTRANT WHETHER FORESEEABLE OR NOT AND WHETHER BASED UPON NEGLIGENCE OR OTHERWISE.
- All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and sponsor in connection with the Raffles, shall be governed by, and construed in accordance with, the laws of the State of Georgia, without giving effect to any choice of law or conflict of law rules (whether of the State of Georgia or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Georgia.
- Released Parties are not responsible for stolen, late, incomplete, illegible, misdirected, lost, damaged, garbled, delayed, undelivered, inaccurate, or garbled entries. Released Parties are not responsible for lost,

interrupted or unavailable network, server, Internet Service Provider (“ISP”), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Raffle, including, without limitation, errors or difficulties occurring in connection with the administration of the Raffle, the processing of entries, or in any Raffle-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Raffle. Released Parties are not responsible for injury or damage to Entrant’s or to any other person’s computer related to or resulting from participating in this Raffle.

- Entrants who tamper with, or abuse, any aspect of the Raffle or attempt to undermine the legitimate operation of the Raffle, or intend to annoy, abuse, threaten or harass any other Entrant or Sponsor’s representatives or who are in violation of these Official Rules, as solely determined by Sponsor, will be disqualified and associated entries will be void. Any attempt to deliberately damage the content or operation of this Raffle is unlawful and subject to legal action by Sponsor, and/or their respective agents.
- **CAUTION: ANY ATTEMPT BY AN ENTRANT TO UNDERMINE THE CONTENT OR LEGITIMATE OPERATION OF THIS CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES (INCLUDING ATTORNEYS’ FEES) AND OTHER REMEDIES FROM ANY SUCH ENTRANT TO THE FULLEST EXTENT PERMITTED BY LAW.**
- The Sponsor reserves the right, in its sole discretion, to cancel or suspend the Raffle for any reason, including should virus, bugs, unauthorized human intervention, or other causes corrupt the administration, security, fairness, integrity or proper operation of the Raffle.
